Water is on everyone's minds

Well, after Bourke just got 94 mm of rain and Armidale got 3 mm, I guess we can safely assume that the weather world is a little strange at present. Of course, this is the most serious drought that any of us living on the Northern Tablelands have experienced.

But, as they say, "It's an ill wind that blows nobody any good". At least we know that finding more water is a 'hot topic'! There isn't a conversation today in this area where the topic of water does not come up. This means, we have an opportunity to raise important issues about Armidale's and the region's water supply and the lack of environmental flows, including through our city.

With the benefit of hindsight, we might conclude that we have been somewhat complacent since Malpas dam was built over 50 years ago in 1968. Plans to consider doubling its capacity have been mooted by our local member, Adam Marshall.

As we know, Armidale has experienced other serious water crises in the past and we need to reflect on that history as well as on the current drought. For example, the 1940s were a particularly severe period for the region and city. The water supply was replenished finally in 1954 - having been commenced 1947 - by the construction of the Gara River Dam with a capacity of 346 ML or 2.7% of the capacity of Malpas Dam!

Let's all encourage our Local, State and Federal governments to think strategically about the stuff of life - water - and encourage them to seek ideas from the community. Let us together come up with sensible multi-generational plans that will allow our beautiful city, towns, farming and natural areas to thrive into the future. We have so many invaluable assets - including human capital - in this region and we need to maintain a positive frame of mind to overcome the current obstacles; just like our forebears did!

It is surely a daunting task for our Local government Councillors and Council officers to manage us through the current water crisis in our region. No doubt we are all supportive of measures to save water and plan for the full range of possible rainfall scenarios over the coming months and years.

Still, in spite of these challenges, we trust that Council will continue to pursue its city-wide Master Planning process so that we forge solutions, even in this current climate of considerable adversity.

No doubt our members are aware of the huge challenges being faced each day by our farmers as well as businesses throughout the region. Our thoughts are with you all.

Report on our July Annual General Meeting

In time, we will circulate some minutes of this meeting. But for now, suffice to say that it was a successful meeting when we heard about plans to recycle water upstream from the east of the city to the west and allow it to flow back through the city for the benefit of all life along the creeklands. We had several new members join our association on the night. The AGM was brief and we managed to elect a full complement of 9 committed members - you can see their photos and read about their wishes for the creeklands at <u>this web link</u>.

You will remember our aim is: "To assist in the careful planning, design and development of beautiful, healthy and safe public spaces featuring wetlands, lagoons and billabongs, connected by flowing water along the Armidale Creeklands".


Since the AGM, we have had two committee meetings with a third coming up in mid November.

What is happening with the city-wide Master Plan?

We support Council's decision to embark on a city-wide Master Planning Process. This is consistent with our submission made to the earlier Creeklands 'Master' Plan which pointed out that the limited scope of the plan (only from Markham to Douglas Streets) was a limitation of that consultancy - our association pointed out at the time, the need to consider the broader issue of where any water might come from.

Two representatives or our association were invited to attend the first city-wide Master Planning meeting on May 3, 2019. You might remember we reported on this meeting in our June 2019 newsletter. We have not yet been informed of the next steps in this process.

Confusion about choice of site for new playground prior to completion of city-wide Master Plan

You may have read in the Armidale Express (during September), conflicting statements about the site for the new playground in Armidale. Your committee approved a Letter to the Editor which was published in the October 30 issue of the Express. We understand the pressures that are brought to bear on Local Government but we wanted to point out the need for any infrastructure to be located in a location consistent with planning processes.

Reaching out to Armidale Regional Council

We acknowledge that, in order to get any proposals to improve the creeklands, we will need the approval of Armidale Regional Council. So, we have sought to engage constructively with Council.

Only one Councillor was able to attend our Presentation at the AGM in July 2019, when we spoke of the idea for recycling water through the city. This suggestion came from Darling Irrigation water engineer, Sam Maroulis, of Dubbo and it was well received at our AGM.

Your committee decided that we should inform Councillors and the CEO of these ideas and so we emailed them suggesting that we might make a short presentation to Council. Even though we got support for such a presentation from 6 Councillors, we await an invitation.

Undaunted, we recently wrote an email to all Councillors and CEO advising them of our key points and provided them all with a copy of Sam Maroulis' proposal.

Reaching out to the local Aboriginal community

Over recent weeks, two of your committee arranged an informal meeting of representatives of the local Aboriginal community. We wanted to start learning something of the history of the creeklands as understood by our region's First Peoples. We hope to continue to meet with representatives so we can develop a common understanding of how we might improve the flows along and health of the creekland stream.

This is consistent with your committee's belief that we need to work hard to build a consensus across the community if we are ever to have any success in coming up with agreed 'Visions for Armidale Creeklands'.

Engaging with the Armidale Urban Rivercare Group

Recently, two of your committee attended the annual Armidale Urban Rivercare Group (AURG) planning meeting at the Armidale Bowling Club. This was of great interest to us and we were invited to make a short statement of how we see our Visions association working in a complementary fashion to the AURG. Our statement was well received and we have offered for three representatives of AURG to attend our next Visions committee meeting (November 2019) as observers.

As our members have told us, we appreciate the importance of two groups such as ours working together to improve the creeklands.
