## **Objectives**

Provide attractive prizes for a competition for school students - to attract the interest of students, teachers and parents. Students will be invited to prepare imaginative proposals within topic areas aligned to the curriculum such as: water (health, flow, capture, storage, etc.), bridges (attractive designs, layout, etc.), recreation, nature play areas, entertainment and sport (facilities, events, etc.) or energy (e.g. hydroelectricity, solar pumping, etc.). This competition will encourage intergenerational participation to improve the entire creeklands as a vital artery of our city and region - both now and into the future.

**Develop visual concept plans** for the entire network of creeks that make up Armidale's creeklands. We will identify the areas best suited for the construction of wetlands, ponds, billabongs, walkways, viewing areas, recreational facilities, Aboriginal interpretation sites and historical sites of interest. We will create detailed maps and images of our proposals for water as well as infrastructure and landscape architecture. With sufficient funds, we will engage professionals to carry out water modelling to plan for off-stream water storages and place our Visions and innovative designs within our creeklands landscape.

## Plan

A sponsorship proposal will be sent to a wide array of local businesses/organisations seeking sponsorship at a range of levels specified in the Sponsorship Proposal.

A parallel fundraising campaign will seek financial support from individuals.

Our aim is to raise approximately \$50,000 over the course of a 6-month period to support the activities specified in the Sponsorship Proposal (namely a **competition for school students** and to **develop visual concept plans** for improving the Armidale Creeklands).

If we raise more than the above goal, we will expand the scope of our activities - all of which will be focused on our association's aims and objectives stated in our Constitution (<a href="https://www.armidalecreeklands.org.au/association">https://www.armidalecreeklands.org.au/association</a>).

If we raise less than the above goal, we will trim the scope of our planned activities accordingly. If the funds raised are insufficient, or if unexpected costs arise, not all aims of the proposal may be achieved.

Those making in-kind sponsorship offers will supply evidence that the value of such offers will be approximately equivalent to one of the three cash levels of sponsorship. We will notify those offering in-kind sponsorship if their offer has been either accepted or declined. It is envisaged that some items may be suitable as prizes for the proposed school competition. Alternatively, services may be offered to assist us in developing visual concept plans as explained in the Sponsorship proposal.

The association reserves the right to, in good faith, alter its plans and the methods used to achieve its aims if circumstances require this.

The money raised will not be given to any members apart from reimbursing members for any agreed expenditure that individual members may pay on behalf of the association.

If the association were to wind up, it will disburse any remaining funds to any like-minded not-for-profit bodies, according to provisions specified in its constitution.

Visions for Armidale Creeklands Inc is not a deductible gift recipient and thus sponsorship donations will not attract a tax deduction for the sponsor.

- Acknowledges that the committee may, at their sole discretion, refuse sponsorship
  from any individual or party that they might deem to be unsupportive of the aims of
  this association or may decline some in-kind sponsorship offers. In such cases, if
  sponsorship funds have already been provided, the association will negotiate in good
  faith with any such individual or party to arrange an appropriate refund. The sponsor
  acknowledges that the committee is entitled to deduct administrative, legal,

operational and other costs from any amount (if any) the sponsor would be entitled to receive by way of refund (if payable at law).
